Subject: Report.

Sir,

I have the honour to report that on 18/11/2023 at about 11.00 am, while I along with Hafiz Najir Ahamed aged about 30 yrs S/o. Late. Md. Noorjaman of Lilong Lou Manga were cleaning at my homestead land, the following three persons namely 1) Md. Islamuddin aged about 54 yrs S/o. S/o. Late. Syed. Umed Ali @ Tomba of Lilong Lou Manga 2) Md. Kheiruddin aged about 50 yrs S/o. -do- of do. and 3) Md. Wajiruddin, 20 yrs s/o Kheiruddin of do had forcibly entered by holding sticks, spade etc. in spite of injunction order issued by the Hon'ble Court. After that I was forcibly dragged by holding my collar and shouted to kill me. Meanwhile, my elder brother namely Md. Abdul Karim, 57 yrs came and confronted the situation. He also got swelling injury on his shoulder while trying to rescue me from them. Later, he was evacuated to Hospital for medical treatment. The act of the above individuals is attempted to kill us.

It is therefore, requested to take up necessary legal action against the above noted culprits.

A copy of the medical report and injunction order are enclosed along with this report.
