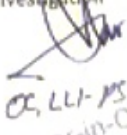

Subject: Request for filing a complaint (Zero-FIR) in c/w recent attacked against me.

Sir,

With due respect, I would like to report a cognizable offence carried out against me and my family on 3rd May around 10:30-11:00pm. Wherein, a large gathering mob of Meitei Community conspired and instigated by Meitei Leepun & Arambai Tenggol of Valley based CSO's attacked on my/our Heikon (Meitei) village and started vandalizing, ransacking and burnt down my/our house rendering me in a state of homelessness. Fearing to lose of our lives and being in a state of vulnerability, I, along with my family members numbering 6 (male) 4 (female) had fled and now taking refuge and shelter at the resident of /Relief Centre L. Semol.

That, the assets/properties and damages were estimated to Rs 17,25,000/-.

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abators for their heinous acts carried out against me and my family.
