Sir,

I have the honour to report that on 30/11/2023 at about 10.00 am my husband namely Md Abdul Noor @ Amjad 38 years s/o late Abdul Samad residence of Lilong Haoreibi Turel Ahanbi Dam Makha left home by driving his Apache motorbike bearing registration not known for his daily business purpose at Grocery Shop, Thangal Bazar Ngarigali. Later on the same day at around 12.34 pm, a telephonic call was received from his own phone bearing phone no : 9366895804 to his cousin brother pone bearing Phone No: 7421064208 namely Nurul Hassan (28) years s/o Nooruddin of Lilong Turel Ahanbi Darul Uloom Wangma and he stated that he was abducted for ransom by some unknown miscreants and kept him somewhere in an unknown place but he did not mention the place from where he was abducted. He further asked to the said Nurul Haasan's through telephonic call to arrange and bring an amount of Rs. 50,00,000 (Rupees fifty lakhs) so as to release him from the said unknown miscreants.

In this situation, I the undersigned beg to state that my husband has been abducted by the said unknown miscreants and concealed him somewhere in an unknown place with his life at risk, as therefore I request you to rescue my aforementioned husband at an earliest and take up necessary legal action against the unknown miscreants.
