Subject- request to register a complaint (Zero F.I.R) in c/w recent attack upon me.

Sir,

With due respect, I would like to report and register a cognizable offence carried out against me on the night of 3<sup>rd</sup> May, 2023 at around 9:00 Pm by Meitei community, who were armed with sophisticated automatic guns like AK's, Rifles, Pistol, Machette and Knife whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of valley based CSOs. Due to such attacked carried out against me, being in vulnerable state. We had fled from our village i.e Nongmaipal, P.O- Porompat and P.S. - Lamlai, District-Kangpokpi on account of fearing to lose our life.

As such, I have been taking shelter at the resident of my eldest Sister namely Domjakhol Lunkhel at Zion Veng, Churachandpur.

On inquiry, my house was ransacked and burnt to ground. Properties were looted and taken away.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my families for the end of justice.
