Subject: - Report.

Sir,

I have the honour to state that today i.e., 23/03/2023 at about 05:00 am received a reliable information from our own source about the presence of some active cadres of PREPAK (PRO) organization an outlawed banned organization in and around Lairenkabi Maning Leikai area. Acting on the information, a team of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW and myself under the supervision of Shri. Dr. S. Ibomcha Singh, MPS, SP-IW rushed to the said area and conducted C.I. operation at Lairenkabi Maning Leikai area. During search at the house of Chandam Thambou of Lairenkabi Maning Leikai, one unknown person was found in a suspicious manner. Due to his suspicious manner, the said person was detained for spot checking and verification. During spot checking, one Redmi 8A mobile handset along with 2(two) SIM cards i.e. (i) one Airtel SIM card bearing number 8991160990013578170U (Ph. No. 8974043680 as disclosed by him) and (ii) one Jio SIM card bearing number 889918650400012386910 (Ph. No. 7005532336 as disclosed by him) was recovered from his possession.

On spot verification, he identified himself as Chandam Chandramani Singh (45 yrs) @ Gambhir S/o. (L) Ch. Thambou of Lairenkabi Maning Leikai. On preliminary verification, he disclosed that he is an active member of PREPAK (PRO) organization and started working for the said organisation around 1(one) year back under the command of s/s commander Mr. Khambaton of PREPAK (PRO) organization, Finance Section (Ph. No. +918798367182) who is presently staying at Myanmar. He further disclosed that he frequently communicates with his commander and under his instruction he served monetary demands to several educational institutions in an around Imphal area. He also disclosed that he was earlier arrested by security forces in the year 2001 as Kanglei Yawol Kanba Lup (KYKL). Further, he also disclosed under the instruction of his commander he recruited one Sorokhaibam Khamba Meitei of Lairenkabi Mamang Leikai as a active member of their organisation around 2(two) weeks back and he (Chandramani) was further instructed by his commander to bring him (Khamba) at Myanmar for performing their party activities. Hence, he was arrested at the spot at 06:00 am and the recovered article was seized at 06:10 am by observing formalities.

Immediately, our team along with the arrestee rushed to the house of Sorokhaibam Khamba Meitei located at Lairenkabi Mamang Leikai and successfully detained him at his house as pointed out by the arrestee for spot checking and verification. On spot checking, one Jio mobile handset along with one Jio SIM card bearing number 89918650400106684089 (Ph. No. 7005171099 as disclosed by him) was recovered from his possession. During spot verification, he identified himself as Sorokhaibam Khamba Meitei (46 yrs) S/o. S. Narsingh of Lairenkabi Mamang Leikai. During preliminary verification, he disclosed that he is an active member of PREPAK (PRO) organisation and joined the said organisation for about 2(two) weeks back through the above mentioned arrestee namely Chandam Chandramani Singh of Lairenkabi Maning Leikai of PREPAK (PRO) organisation and presently working under the command of s/s commander Mr. Khambaton of PREPAK (PRO) organization, Finance Section (Ph. No. +919233084570) and he frequently communicates with his commander. He further disclosed that Chandam Chandramani Singh told him to go with him (Chandam Chandramani Singh) to Myanmar by their commander for performing their party activities. Hence, he was arrested at the spot at 07:00 am and the recovered item was seized at 07:10 am by observing formalities.

The arrested persons along with the seized articles are handed over to you for taking further necessary legal action against him.
