I Mr. Lamtinthang Thangboi son of Rev. Douseh Hmar residing at Hebron Veng, Phaipijang village, Langol herby register this First Information Report (FIR) under section 425 of the Indian Penal Code

Incident Details:

On date 5th May 2023 at approximately 10:00 AM, my house, along with all the properties was burnt down by unidentified individuals, suspected to be from the Meetei community. The incident resulted in the following damages:

- 1. House: The house, estimated to be worth Rs. 800,000/- (Eight Lakhs) was completely destroyed by the fire.
- 2. GI Sheets: Six bundles of GI Sheets valued at Rs. 21,000/- were burnt down
- 3. Wooden Almirah: One wooden almirah valued at Rs. 30,000/- was damaged beyond repair
- 4. Gas Cylinders: Two gas cylinders with Stove valued at Rs. 15,000/- were also destroyed in the fire
- 5. LED TV 40 cm valued at Rs. 55,000/- was burnt down
- 6. Syntex 2000 litres: A pair of Syntex (2000 litres each) valued at Rs. 30,000/- were burnt down
- 7. One bed box valued at Rs. 25,000/- was burnt down
- 8. Laptop: One HP Laptop with Epson Printer valued at Rs. 60,000/- were destroyed and burnt
- 9. Kitchen materials valued at Rs. 200,000/- were totally burnt down
- 10. Clothes: Valued at Rs. 100,000/- totally burnt down
- 11. Misc.: valued at Rs. 60,000/- were burnt down Total: Rs. 13,96,000/- (Thirteen Lakhs Ninety Six Thousand)only

Description of the Incident:

During the specific date and time, I was unable to be present at the precise location due to concerns for personal safety arising from a communal clash between the Kukis and the Meeteis. However, I received information regarding the incident from neighboring individuals. The nature of the occurrence suggests an intentional act of arson, and based on preliminary information, there is suspicion regarding the involvement of individuals from the Meetei community. Furthermore, it is important to note that the destruction of houses was not limited to mine alone; all houses belonging to the Kukis tribes were deliberately set the fire by perpetrators believed to be Meetei.

Suspected Persons:

At present, the identity of the suspected person(s) responsible for the incident in unknown. However, based on preliminary information, individuals from the Meetei community are suspected to be involved. The investigation should be focus on identifying the perpetrators and collecting any possible evidence related to the incident.

Request for Investigation:

I hereby request the police department to conduct a thorough investigation into the matter. It is crucial to identity and apprehend the individuals responsible for this heinous act of arson. I request that necessary measures be taken to recover the losses incurred and provide me with the required support during this distressing period.

Conclusion:

This FIR is registered to document the incident and initiate the investigation process. I urge the authorities to expedite the investigation and take appropriate action to bring the culprit to justice. Any updates or progress in the case should be promptly communicated to me.
