This is to report that on the 4th of May at around 3 PM, a Meitei mob numbering around 3000 individuals armed with deadly rifles, machetes, sticks and clubs stormed the gate of Khongsai Veng. The mob engaged in murder, destruction and theft of properties in the locality indiscriminately. In the events that unfolded, my carpentry house at Khongsai Veng constructed on lease at Plot 18 was ransacked, destroyed and looted of every little valuable possessions in it then burned to the ground.
