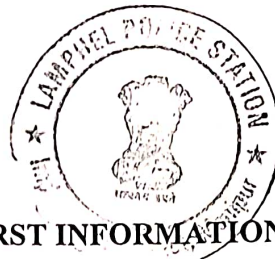



Subject: Complaint report.

Sir,

I am to state that, on 4<sup>th</sup> May 2023 at about 3: 00 pm, our locality Khongsai Veng, Laipham Khunou under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with criminal intention to cause damage of property and life. They were armed with deadly weapons including automatic rifles, SBBL, knives, etc.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. Among which my house NO. 90 (rent) was also destroyed by the mob, many properties were burnt and leftovers were looted.

Lists of properties (both immovable & movable) looted, burnt and destroyed are given below:

1. Gold & Jewellery (one necklace and two earrings)
2. Furniture includes 2 wooden Almira, 1 Godrej steel Almirah, 2 Wooden beds, one Sofa sets, one dressing table, one TV stand, one Dining set, 3 jumbo box.
3. 2 bags of rice.
4. One Maruti Omni Van B/R.No. MN05A-3037
5. Traditional ornament includes- Two necklace (Khiba) and One Gong.
6. One Misao Gas connection, cylinders-2 nos and 1 stove.
7. Electronic items- 1 Television, 1 Fridge, 1 Washing machine, 1 Oven.
8. Cash- 1,00,000/-
9. Miscellaneous

The approximate total loss of properties would be Rs 19,50,000 Lakhs.

It is, therefore, kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
