That on 30th March 2023 @ 5.00 pm 2 (two) persons identified as (1) Waikhom Bikramjit Singh (24) S/o W. Babu Singh of Khurai Chingangbam Leikai and (2) Maibam Deepu Meitei (24) S/o M. Ibomcha Singh of Khurai Salanthong, as per the agreed norms of Angom Rental Service took on rent under formality (1) i 20 White B/Regdn. Robindro Meitei of Taothong Ayungba and (4) Lairenmayum Shantikumar Singh (28) S/o L. Nena of Lambal at the house of Thangjam Samanda Singh (37) S/o (L) Manaoton Singh of Heibongpokpi Maning Leikai by giving another fake duplicate Registration Card which also stands in the same name and my particular (as produced by Thangjam Samanda Singh 37 yrs. S/o (L) Manaoton Singh of Heibongpokpi Maning Leikai). So the vehicle i20 White B/Regdn. No. MN01G/6803 was trace out and recovered from the house of Thangjam Samanda Singh 37 yrs. S/o (L) Manaoton Singh of Heibongpokpi Maning Leikai on this day ie. 11-4-2029 at 10.50 pm with the help of Lamsang Police team and another rented vehicle Baleno Metallic Silk B/Regdn. No. MN06LB4768 is yet to be trace out.
