Today i.e. 13/04/2023 at 06:50 pm received a reliable information that on the same day @ 06:30 pm, one Honda Activa-i B/Regdn. No. MN01V0363 White in colour ridden by an unknown person coming towards Lamsang Bazar side was knocked down at Taothong Lamkhai near Public Girl High School along Uripok Kangchup road by an unknown vehicle (seems to be TATA 407) coming in the same direction and fled away from the spot. As a result of which the unknown rider of Honda Activa-i sustained injury on his person due to rash or negligence driving on the part of both the unknown driver and rider of vehicle (seems to be TATA 407) and Honda Activa-i B/Regdn. No. MN01V0363 White in colour. The injured person was evacuated to Hospital for further Medical Treatment and also caused partly damaged of Honda Activa-i B/Regdn. No. MN01V0363 White in colour.
