Subject: - Report.

Sir,

I am to report that today i.e. 27th April, 2023 at about 10:00 a.m. received a reliable information about the presence of some anti-social elements in and around Lamshang, Imphal-West District. Based on the said information, a team CDO/IE led by myself rushed to the said area after providing prior information to Control Room Imphal West District Police and conducted a random frisking and checking to the suspected passersby at Haorang Sabal Makha Leikai near Millennium garden. In that one suspected person was detained for verification and checking. On verification, the detainee identified himself as one **Talem Sushilkumar @ Sushil @ Bobo (30 years) S/o T. Nila Singh of Haorang Sabal Makha Leikai, Imphal-West District.** On checking his body, found one mobile phone from his possession.

On further verification, the detainee disclosed that he is an active member of the outfit KCP who joined the said outfit through one Athouba of KCP in the year 2022 and presently working under his command. He further stated that he worked at Manipur Development Finance & Investment (MDFI) as Loan Manger since 2018. He further stated that he had shared all the information of his office i.e. MDFI with the said Athouba of KCP and in co-ordination with the said Athouba of KCP he had collected money from the general public and private firms. He further stated that on the instruction and advice of the said Athouba of KCP, he had registered a land at Hiyangthang, Imphal-West which was the property of their office ie. MDFI to his younger brother namely; Talem Bobby @ Nanao, aged about 25 years, s/o T. Nila Singh of Haorang Sabal Makha Leikai, Imphal-West District and other two person namely; (i) Soram Somorjit Singh (42) S/o S. Amuba Singh of Naran Konjil Makha Leikai, and (ii) Wahengbam Rojita Devi (30 years) W/o - W. Mutum Puremcha Meitei of Lamdeng Thongkhong, Imphal-West.

So, the detainee was arrested from the spot i.e. Haorang Sabal Makha Leikai near Millennium garden at 11:10 a.m. and seized one mobile phone (Oneplus Nord C2 Lite) bearing IMEI no. 861871068312331 & 861871068312323 along with one Jio SIM card bearing no. 89918650400017751720 at 11:20 a.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being hand over to you for taking up further necessary legal procedures against him.
