Today i.e. 28-04-2023 at 1:20 pm received a reliable information that on the same day @ 01:10 PM one two wheeler Destini 125 Blue in colour B/ Regd. No. MN01 AN 1010 ridden by unknown person coming from Lamdeng towards Kameng side collided with one TATA Truck (six wheeler) B/ Regd. No. AS 01CC 2259 driven by an unknown driver moving in opposite direction at Lamdeng Awang Leikai near Forest Beat due to rash or negligence driving on the part of both the unknown rider and driver of two wheeler Destini 125 Blue in colour B/ Regd. No. MN01 AN 1010 and TATA Truck (six wheeler) B/ Regd. No. AS 01CC 2259. As a result of which the unknown rider and pillion rider of the two wheeler Destini 125 Blue in colour B/ Regd. No. MN01 AN 1010 sustained serious injury on their persons and evacuated to Hospital for medical treatment and also caused damaged of two wheeler Destini 125 Blue in colour Bearing Regd. No. MN01 AN 1010.
