I have the honour to state some few words that on 6/5/2023 at 6:30 pm my son namely Yumtsham Premananda Singh (16) s/o Y. Chalamba Singh of Phunlou Awang Leikai get serious injury on his both left & right leg while he was trying to escape from the counter firing took place between the two communities (Meitei & Kukis) and fall down in a pit inside the campus of the NSO, Kouruk and evacuated to hospital for treatment. We could not report on time as the tense between the two community is very high and due to the imposing of curfew as well as my family members were engaged for the Medical Treatment of my son.

Therefore requested you to kindly take necessary action.
