

Today i.e. 23/02/2023 at about 05:40 pm received reliable information that on the same day at about 05:30 PM one unknown cyclist was knock down by an Alto car 800 B/Regn. No. MN06LA 2927 Grey in colour which was driven by unknown driver near Aleza Hotel, Phayeng along UK Road which was coming from Phayeng towards Imphal side and fled away from the spot. As a result the unknown cyclist sustained serious injury on his person due to rash and negligence driving on the part of the unknown driver of the Alto car 800 and the injured person was evacuated to RIMS Hospital for Medical Treatment where the unknown cyclist declared as brought dead. The involved vehicle and the bicycle were also partly damage.

Hence a Suo-Motto case under FIR NO. 3(02)2023 LSG-PS U/S 279/338/427/304-A IPC has been registered for investigation.
