I am to state that on 26/02/2023 at about 05:00 am a specific input received from 4th Assam Rifle regarding presence of one suspected person of Gangs in General area of Haorang Khunou Mayai Leikai Imphal West Dist. On receiving the information a teams of Special Commando Unit, Khabeisoi led by Subedar L. Bebekananda Singh Officer-In-Charge Special Commando unit, Khabeisoi including myself, under the supervision of Shri Th. Krishnatombi Singh, MPS, Superintendent of Police/Railway & In-Charge Special Commando Unit, Khabeisoi rushed to the said area and started frisking operation in the area. On checking the detainee, 1(one) Small arm and one mobile phone Key pad (Kechaoda) bearing IMEI no.863816020292459/863816020292467 along with 1(one) Airtel SIM card having mobile no.9233636233 were found from his possession. On further verification, the detainee stated that he is an Gangaeader and threatening to construction site of National Railways Project workers, trying to set ablaze one JCB at Warousabal and disturbing to the General Public along with one small arm suspected to be Plastic Gun in the year October 2022.

So, from the above facts and circumstances he was arrested at the spot at 05:40 am of 26/02/2023. And the above items was seized at 05:45 am.

The arrested person and seized items are hand over to you for further legal action against him.
