I have the honour to state some few words that on 18/02/2023 at around 8:10 pm while I along with my wife and son namely Ahanthem (N) Moirangthem (O) Anuradha Devi (40) w/o M. Roshan Singh of Sagolband Meino Leirak and Moirangthem Tomthinnganba Singh (10) S/o M. Roshan Singh of Sagolband Meino Leirak were returning home from Heibongpokpi towards Imphal side on my two wheeler TVS Jupiter B/Regd. No. MN01V 7392 after visiting my father in Law residence at Heibongpokpi suddenly we were knock down by one Bolero Pickup B/Regn. No. AS25DC /1455 which was coming from Phayeng side on the back side of my vehicle at Heibongpokpi near Community hall due to rash and negligence on the part of the driver of the Bolero pickup B/Regn No. AS25DC /1455. In that I along with my family sustained serious injury and evacuated to Hospital by the Localities and further refer to Raj Medicity for further medical treatment. My two wheeler vehicle TVS Jupiter was badly damaged. I could not report on time as my family members were heavily engaged at hospital.

Therefore kindly help me find out the unknown driver of the Bolero pickup B/Regn No. AS25DC /1455 at the earliest. I would be thankful for your kind consideration.
