With due respect, I have the honour to report that on 08/12/2023 at @ 12,30 PM my only son namely Laishram Chinglen Singh (21 yrs) studying in B.Sc 3<sup>rd</sup> semester was kidnapped by some unknown armed miscreants suspected to be valley based underground outfits from DM College of Science New Boys hostel Room No. 36. Later on, I received a phone call at 01.32 PM from my son's phone and the unknown persons instructed me to come along with my wife at Hiyangthang area. Immediately, I along with my sister-in-law namely Laishram (O) Chaoba Devi (47 yrs) W/O L. Ojit Singh of Ngaikhong Siphal Mayai Leikei, Bishnupur Ward No. 8 went to the said place and we met the unknown armed miscreants at Kamakhya Pemton College Hiyangthang. The unknown armed miscreants threatened both of us at gun point by using a small arm and demanded to pay a sum of Rs 15,00,000/- (Fifteen Lakhs only) as a ransom to release my son, otherwise we would see the dead body of my son on the next day.

It, is therefore, requested your good self to kindly rescue my son at the earliest and to take up necessary legal action against the unknown armed miscreants.
