With due respect, I have the honour to report that I have been getting threat calls and disturbing unpleasant messages since 26<sup>th</sup> Nov, 2023 from two different mobile No. 9089427629 & 8837344690 in my mobile No. 7085531704. The said caller threatened me to come out during the night from my room to fulfill his wish, if not I will face with dire consequences. The unknown caller used to give 10/20 miss call every night. It is highly suspected that the crime is committed by my neighbor Thokchom Inaocha Singh (47) yrs S/O Th. Chaotombi Singh of Uripok Laikhulembi Leikai, P.O & P.S - Imphal who is a habitual offender. As, a result of the unpleasant messages and calls from the above mentioned phone number which amounts to tarnish my social status/images and outrage modesty, I am mentally and physically disturbed. And even I could not go out from my house during the night time due the threat and behavior of the above mentioned neighbor. Now, I am under medical treatment because of the trauma caused by the above mentioned suspected culprit.

It, is therefore, requested your good self to kindly take necessary legal action against the above mentioned suspected culprit.
