

Subject: - Report.

Sir.

I have the honour to state that today i.e., 09/03/2023 at about 08... am, on receipt of a reliable information about the presence of some illegal Myanmar nationals in and around Phayeng Kharang Khunou, a team of CDO-IW led by Inspector P. Achouba Meeter OC-CDO- W and myself along with women police personnel under the supervision of Shri M. Amit Singh, MPS, A. Al. SP (Ops.)/IW rushed to the said area and conducted corden and search operation at the said area. During search at the house of one Angom Chinglen (34 yrs) S.o. A. Ningthem Singh of Phayeng Kharang Kho nou, 2 (two) persons including a woman were detained at the spot for verification and checking as the couldn't speak the local language. On spot verification they identified themselves as (1) Limdai Aerr (33 yrs) @ Thougkhosei Hangsong @ Solomon Merr S/o. Limpoiline Merr of Leshi/Layshi Township, Sagaing Region, Myanmar and (2) Veikhohat Hatnu (29 yrs) W/o. Limdai Merr of Leshi/Layshi Township, Sagaing Region, Myanmar. On spot checking of Limdai Merr, one suspected forged Aadh r card bearing no. 411841548371 and one Redmi 10 mobile handset along with 2(two) SIM cards i.e. (i) c. e Airtel SIM eard bearing no. 8991160990020372886U (Ph. no. 9233145909 as disclosed by him) and (ii) one ORETOO SIM card bearing no. 899504540000601972651 (Ph. no. +959982911591 as disclosed by him) were recovered from his possession. On spot checking of Veikholmt Hatnu by women police personnel. one suspected forged Aadhar card bearing no. 236182718250 and one Redmi Note 9 mobile handset along with 2(two) SIM cards i.e. (i) one Airtel SIM card bearing no. 8991160990011987522U (Ph. no. 8119081291 as disclosed by her) and (ii) one ORETOO SIM eard bearing no. 89950540000617871121 (Ph. no. +959970508254 as disclosed by her) were recovered from her possession.

During further verification they disclosed that they were brought by the above mentioned house owner namely Angom Chinglen from Dimapur in the month of February, 2023 and they stayed at the house of Angom Chinglen's wife located at Nonpok Semkai area for some day and later on they have been staying at his house at Phayeng Kharang Khunou since 6<sup>th</sup> March, 2023. They also disclosed that the above recovered suspected forged Andhar cards were made with the help of his grandfather namely Zion Merr (Ph. no. 9862261346) who is presently staying at Mimi Village, Kiphire District, Nagaland. They were unable to produce any valid documents for entering and staying in India while they were asked to

On spot verification of Angom Chinglen (34 yrs) S/o. A. Ningthem Singh of Phayeng Kharang Khunou, he disclosed that he brought the above mentioned 2(two) Myanmar nationals from Dimapur and kept them at his house. On spot checking, one VIVO Y15 mobile handset along with 2(two) SIM cards i.e. (i) one Jio SIM card bearing no. 89918650500010485828 (Ph. no. 9863090414 as disclosed by him) and (ii) one Airtel SIM card bearing no. 8991160990009344627U (Ph. no. 6909651551 as disclosed by him) were recovered from his possession. One Maruti Van silver in colour bearing MN03A 3897 was also recovered from his house which was used in transporting them from Nongpok Sekmai to Phayeng Kharang Khunou.

Hence, Limdai Merr (33 yrs) @ Thongkhosei Hangsong @ Solomon Merr, Veikhohat Hatnu (29 yrs) and Angom Chinglen (34 yrs) were arrested at the spot at 09:30 am, 09:40 am and 09:50 am respectively and the recovered articles were seized from their possession at 09:35 am, 09:45 am and respectively.
