Today i.e. 22/08/2023 at 4:40 pm received an information that on the same day at around 3:30 pm, one Super Carry bearing regn. AS11CC 9280 driven by unknown driver plying from Kanglatongbi towards Imphal side hit one Honda Activabearing Regn. No. MN01AE 7089 ridden by unknown rider which was plying from Sekmaitowards Kanglatongbiside and simultaneously hit the Honda Activa by one Maruti Van bearing regn. No. MN01W 5197 which was driven by unknown driver plying from Imphal towards Kanglatongbi side at Sekmai Bazar in front of Auto parking along NH-2, due to rash and negligent driving on the part of unknown drivers of Super Carry bearing regn. AS11CC 9280 and Maruti Van bearing regn. No. MN01W 5197. As a result of which the rider of the Honda Activa received injury on his person and immediately evacuated to Hospital for medical treatment as well as the vehicles got damaged.

Hence a regular sou-motto case under FIR No. 267(8)2023 SEK-PS U/s 279/338/427IPC has been registered for investigation.
