With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Co-Operative, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May, 2023. Due to the ongoing communal crisis between two communities, on 30/5/2023, I along with my whole family had fled away from my house due to fear & safe of our life and taking shelter at Kanto Sabal.

However in the intervening night of 23/6/2023 & 24/6/2023 some unknown persons suspected to be Kuki militants holding sophisticated weapons had trespass my house and vandalized my house and household properties as well as looted many valuable properties i.e furniture items, electronics items, kitchen items, utensil items, clothing, paddy rice- 10 properties that were Vandalized & looted is about Rs 5,00,000/ (Five Lakh).

Regarding the matter, I couldn't able to report timely to your good office due to present ethnic communal violence in the state.

It is therefore requested you to kindly take up necessary legal action.
