Sir,

With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May, 2023. Due to the ongoing communal crisis between two communities, on 7/5/2023, I along with my whole family had fled away from my house due to fear & safe of our life and taking shelter at Kanto Sabal.

However, on 21st August, 2023, it comes to light that, my house cum furniture shop were vandalized by unknown persons suspected to be Kuki militants holding sophisticated weapons in between 7th May, 2023 to 21st August, 2023 and also looted many valuable properties i.e machinery of furniture shop, electronics items, kitchen items, utensil items, clothing, 3 (three numbers of generator). The approximate value of the properties that were Vandalized & looted is about Rs 6,00,000/ (Six Lakh).

Regarding the matter, I couldn't able to report timely to your good office due to present ethnic communal violence in the state.

It is therefore requested you to kindly take up necessary legal action.
