Sir,

With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3<sup>rd</sup> May, 2023. Due to the ongoing communal crisis between two communities, on 4/5/2023, I along with my whole family had fled away from my house due to fear & safe of our life and taking shelter at Kanto Sabal.

However, on 21<sup>st</sup> August, 2023, it comes to light that, my house cum grocery shop were vandalized by unknown persons suspected to be Kuki militants holding sophisticated weapons in between 7<sup>th</sup> May, 2023 to 21<sup>st</sup> August, 2023 and also looted many valuable properties i.e all the goods of grocery shop, electronics items, kitchen items, utensil items, clothing, 7 gas cylinder, Gold (approx. value Rs 50,000), cash (Rs 5,00,000) & important documents etc. The approximate value of the properties that were Vandalized & looted is about Rs 15,00,000/ (Fifteen Lakh).

Regarding the matter, I couldn't able to report timely to your good office due to present ethnic communal violence in the state.

It is therefore requested you to kindly take up necessary legal action.
