Sir,

With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Ex- Serviceman Colony, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May, 2023. Due to the ongoing communal crisis between two communities, on 4/5/2023, I along with my whole family had fled away from my house after proper locked & key of house gate due to fear & safe of our life and taking shelter at Khurkhul village.

However, on 23rd August, 2023 at @ 10:30 am, I am visited at my house for checking with the help of Leimakhong Army and found that, the key of my house gate was destroyed. After thoroughly checking it is learnt that, my household properties i.e Refrigerator-1, Washing Machine-1, Car Wash Machine-1, water pump set-1, welding machine-1, Iron cutter machine-1, drilling machine-1, TV (Sony) - 1, Laptop (apple)-1 and utensil items was found missing from my house which are suspected to be looted by the kuki armed militants in between 4th May, 2023 to 23rd August, 2023. The unknown persons also partly destroyed my house boundary wall fencing. The approximate value of the properties that were looted is about Rs. 2,50,000/ (Rupees Two Lakh Fifty thousand) approximately.

It is therefore requested you to kindly take up necessary legal action.
