Sir,

With due respect, I have the honour to report the following few lines that, on 29<sup>th</sup> May 2023 at around 1:30 pm, some unknown persons suspected to be Kuki militants opened fire towards Meitei populace area of Engourok Chingmang, Kanto Sabal and Leimakhong Chingmang and burnt/vandalized many houses of Meitei community. In that incident of firing several bullets reached our village as well as my house. As such, on the same day I along with my whole family had fled away from my house due to fear & safe of our life and taking shelter at Kanto Sabal relief camp.

However, on 20<sup>th</sup> August, 2023 at @ 11:30 am, I along with Laishram Khemashwori Devi & Kangjam Rati Devi of Kanto Sabal visited at our respective houses for checking and found that my house was partly vandalized and looted many valuable properties which was suspected to be vandalized & looted by Kuki armed militants/miscreants in between 29<sup>th</sup> May, 2023 to 20<sup>th</sup> August, 2023.

**The properties that were vandalized & looted are as follows:-**

1. 8 numbers of Gas Cylinder = (8x Rs 2500) = Rs 20,000/-approx
  2. GI Sheet, 91 piece = Rs 1,56,000/- approx.
  3. Paddy Rice Bag 30 = (30 x Rs 1500) = Rs 45,000/- Approx
  4. Utensil items = Rs 33,000/- Approximately
  5. Clothing items = Rs 26,000/- Approximately
- Grant total = Rs 2,80,000/- approximately**

It is therefore requested you to kindly take up necessary legal action.
