With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3<sup>rd</sup> May, 2023. Due to the ongoing communal crisis between two communities. On 4/5/2023, I along with my whole family had fled away from my house after proper locked & key of my house due to fear & safe of our life and taking shelter at Kanto Makha Leikai Relief camp. On 23/08/2023, it comes to light that, suspected to be Kuki arms militant and Kuki rioters had trespass my house and looted my properties i.e furniture items, kitchen items, utensil items, clothing, electronics items, Cash (Rs. 1 lakh), jewelry by breaking the Lock and key which I had locked. The approximate value of looted & vandalized properties are estimated at Rs.2, 00,0000 /- (Rupees Twenty Lakh) approximately.

It is therefore requested you to kindly take up necessary legal action.
