With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3<sup>rd</sup> May, 2023. Due to the ongoing communal crisis between two communities. On 4/5/2023, I along with my whole family had fled away from my house after proper locked & key of my house due to fear & safe of our life and taking shelter at Kanto Makha Leikai Relief Camp, IW. On 18/06/2023 at 11:44 pm, it comes to light that, suspected to be Kuki arms militant and Kuki rioters had trespass and burnt down my house and all my household properties i.e furniture items, kitchen items, utensil items, clothing, electronics items and one Bike Bajaj Pulsar bearing regn. No. MN01M-9739 under locked and key which I had locked. The approximate value of ~~house~~ & vandalized properties are estimated at Rs. 18,00,000/- (Rupees Eighteen Lakh) approximately.

It is therefore requested you to kindly take up necessary legal action.
