I have the honour to state that today i.e., 26/08/2023 at about 06:00 am, received a reliable information from our own source about the presence of some arms and ammunitions at Pheidinga area near Stone Crusher. Based on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS Addl. SP(Ops.) IW and under the supervision of Shri Dr. S. Ibomcha Singh, MPS, SP-IW rushed to the said area and conducted search at the said area. During the search, the said team recovered one suspicious rice sack which was abandoned at the eastern road side of Pheidinga near Stone Crusher along Imphal-Dimapur National Highway. - ii) 1 (one) no. of 7.62 MM SLR Rifle bearing body 18057709,
- iii) 2 (two) nos. of magazines of 7.62 MM SLR Rifle,
- iv) 19 (nineteen) nos. of 7.62 MM SLR Rifle ammunitions and
- v) 1 (one) no. of .32 pistol marked with "MATE IN CHINA." along with one magazine loaded with 4 (four) nos. of .32 ammunitions.

Hence, the above recovered articles along with the above mentioned rice sack were seized from the spot at 07:00 am by observing formalities.

Hence, the seized articles are handed over to you for taking further necessary legal action.
