With due respect, I have the honour to report the following few lines that, I am residence of Kyamgei maning Leikai, Imphal East district. Now I was staying at my wife home located at Kanto Sabal since 2008. On 29 May 2023 at around 2:50 PM, suspected to be a Kuki militants along with sophisticated weapons, have open fired toward Meitei populace at Kanto Sabal area. In that, I received bullet injury on right big toe and Index toe. As a result of which I have got injured and evacuated to Primary Health center, Khurkhul. Later, after 2 days of the incident occurred, I went to RIMS hospital for further treatment.

Regarding the matters I could not register my F.I.R timely due to lack of legal Knowledge and my medical treatment. It is therefore requested you to kindly take up necessary legal action.
