With due respect, I have the honour to report the following few lines that, I am resided at Ingourok Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3<sup>rd</sup> May, 2023. Due to the ongoing communal crisis between two communities. On 3/5/2023 at around 8:30 pm, I along with my whole family had fled away from my house after proper locked & key of my house due to fear & safe of our life and taking Shelter at my wife parental home located at Khurkhul Moirang Lamkhai. On 23/08/2023, it comes to light that suspected to be the Kuki arms militants and kuki rioters had trespass my house and vandalized some portion of my house as well as looted many valuable properties i.e furniture items, kitchen items, utensil items, clothing, electronics items by breaking the Lock and key which I had locked. The approximate value of the properties that were looted/vandalized is about Rs.5, 00000/- (Five Lakhs).

It is therefore requested you to kindly take up necessary legal action.
