

Sir,

With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May, 2023. Due to the ongoing communal crisis between two communities. On 3/5/2023 at around 7:35 pm, I along with my whole family had fled away from my house after proper locked & key of my house due to fear & safe of our life and taking Shelter at kanto Makha Leikai Relief camp. On 24/08/2023, it comes to light that, suspected to be Kuki arms militant and Kuki rioters had trespass my house and looted some properties of Thashi Singlup which was kept at my house.

The properties that were looted are as follows:-

1. GI Sheet, 250 piece = Rs. 5, 00000/- approx.
2. Utensil items = Rs. 201,500/- Approximately
3. Tent house items = Rs. 256,000/- Approximately
4. Cash = Rs. 1,10,000/-

Grant total = Rs. 1,067,500/- approximately

It is therefore requested you to kindly take up necessary legal action.
