Sir,

With due respect, I have the honour to report the following few lines that, I am resided at Engourok Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May, 2023. Due to the ongoing communal crisis between two communities. On 4/5/2023, I along with my whole family had fled away from my house after proper locked & key of my house due to fear & safe of our life and taking shelter at Kanto Sabal Relief camp Imphal west. On 20/08/2023, it comes to light that from my neighbor (Nepali), suspected to be Kuki arms militant and Kuki rioters had trespass my house and looted my properties i.e furniture items, kitchen items, utensil items, clothing, electronics items, Cash (Rs. 3 lakh), jewelry items, one weaving machine and one tailoring machine by breaking the Lock and key which I had locked. The approximate value of looted & vandalized properties are estimated at Rs.5,00,000/- (Rupees five Lakh) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
