

Subject: Report.

Sir,

I, Paogoulam Kipgen PRO of Haokholet Kipgen, MLA Saitu A/C, while travelling from the MLA Quarter at Babupara, Imphal towards Hengbung village along with the MLA and his family members, staff of the MLA and civilian from 1<sup>st</sup> MR, Imphal for evacuating under the security convoy provided by the Assam Rifles, were waylaid and attacked by Arambai Tengol and Leikinthabi villagers at Leikinthabi which falls under Sekmai Police Station at around 11pm on the 5th of May 2023. Our first horrific encounter of the night started when several Meeteis blocked the road at the place mentioned above. They tried to get us out of our vehicles. When we refused to comply, they started attacking us with knives and machetes. As we tried to flee, we came under heavy firing and pelting of stones. The attack continued until we reached Gamgiphai safely. We were attacked at several other locations. Fortunately, there were no casualties apart from the injuries sustained by a few. However, several trucks including private vehicles given below got damaged. The matter could not be reported timely as the Hon'ble MLA was out of station engaging in various official works.
