

With due respect, I have the honour to report the following few lines that, I am a residence of Kanto Sabal, IW district. On 29/06/2023 at around 1:25 pm some unknown arms persons suspected to be Kuki militants opened fire towards Meitei populace area of Kanto Sabal, IW and looted/vandalized many houses of Meitei. In that, the unknown arms persons suspected to be Kuki militants had trespass my house and looted many valuable properties like furniture items, kitchen items, utensil items, clothing, electronic items, 6 nos. of pigs, 20 nos. of hens and 30 nos. of ducks. The approximate value of looted properties are estimated at Rs. 3,35,000/- (Rs. Three Lakh thirty five thousand) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
