In that, the unknown arms persons suspected to be Kuki militants had trespass my house and looted many valuable properties like furniture items, kitchen items, utensil items, clothing, electronic items, 6 nos. of pigs, 20 nos. of hens and 30 nos. of ducks. The approximate value of looted properties are estimated at Rs. 3,35,000/- (Rs. Three Lakh thirty five thousand) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
