

Today i.e. 30/8/2023 from 11:30 am to 2:00 pm a combined team under the command of Shri M. Amit Singh (MPS) Addl. SP (Ops) IW, a team of Sekmai PS led by Inspt. Ng. Johnson Singh OC Sekmai PS, two teams of CDO-IW, a column of 4th Assam Rifles and a team of 165 TA under the overall supervision of Dr. S. Ibomcha Singh (MPS) SP-IW have conducted searched operation and area sanitisation at Chambirok Hill range, Tingri Imphal West. During the search operation (1) 8(eight) nos. of HE Grenade without detonator (2) 10 (Ten) nos. of Tube Launching 1A, (3) 2 (Two) nos. of Lathod cell (4) One M16 Rifle without body number and magazine (5) 1 (one) Single barrel gun bearing No. 8E-667-2016 (6) 1 (one) 9mm Pistol without body number (7) 1 (one) .22 Pistol bearing No. 32561 (8) 1 (one) empty INSAS Rifle Magazine (9) 1 (one) empty INSAS LMG Magazine (10) 1(one) Chinese Hand grenade (11) 7 (seven) nos. of 7.62 SLR ammunition (12) 16 (sixteen) nos. of 7.62 AK ammunition (13) 8 (eight) nos. of INSAS ammunition (14) 6(six) nos. of Grenade ring were found abandoned at the foothill of Chambirok and the same has been seized from the spot by observing formalities. Further no untoward incident was happened and no arrest was made during the search Operation.

Hence, a sou-moto case under FIR No. 292(8)2023 Sek-PS U/s. 5-Expl. Subs. Act & 25(1-A) A. Act has been registered for investigation.
