With due respect, I have the honour to report the following few lines that, I am residence of Thanga Heisnam Leikai, Bishnupur Dist: Now I was staying with at a rented house located at Leimakhong Ex-service colony since 2022, IW district which is under the control of Kuki arms militants since the beginning of the current communal riots. Due to the ongoing communal crisis between two communities. On 4/05/2023 at around 5:00 am, I along with my family members have come out from my rented house by keeping my rented house and grocery shop under locked and Key. On i.e 20/08/2023, it comes to light that, suspected Kuki arms militant and Kuki rioters had trespass my rented house and grocery shop and looted/Vandalized my properties i.e furniture, kitchen items, utensil, clothing & electronics items, cash (Rs.60,000/-), jewelry and shop items and others by breaking the Lock and key which I had locked. The approximate value of the properties is Rs. 10,23000/-(Ten Lakhs & twenty three thousand).

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence I therefor reported to your good office for further procedure.

It is therefore requested that you kindly look into the matter and take up necessary action at the earliest
