With due respect, I have the honour to report the following few lines that, I am resided at Kanto Sabal, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May, 2023. Due to the ongoing communal crisis between two communities. On 29/06/2023, I along with my whole family had fled away from my house after proper locked & key of my house due to fear & safe of our life and taking shelter at Kanto Makha Leikai Relief Camp. On 20/08/2023, it comes to light that, suspected to be Kuki arms militant and Kuki rioters had trespass my house and all my household properties i.e furniture items, kitchen items, utensil items, clothing, electronics items,1 cow, 1 Ox and 3 calf under locked and key which I had locked. The approximate value of looted & vandalized properties are estimated at Rs. 5,20,000/- (Rupees five Lakh twenty thousand) approximately.

It is therefore requested you to kindly take up necessary legal action.
