Sir,

With due respect, I have the honour to report the following few lines that, I am a residence of Kanto Sabal, IW district. Now I was staying at rented house owned by Awon located at Leimakhong Chingmang since 2014 which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e. 3rd May, 2023, 2023. Due to the ongoing communal crisis between two communities. On 04/05/2023, I along with my whole family had fled away from my rented house after proper locked & key of my rented house due to fear & safe of our life and taking shelter at Kanto Sabal Relief camp Imphal West. On 18/06/2023 at around 11:50 pm some unknown arms persons suspected to be Kuki militants and Kuki rioters opened fire towards Meitei populace area of Leimakhong Chingmang, IW and looted/vandalized many houses of Meitei. In that, the unknown arms persons suspected to be Kuki militants and Kuki rioter had trespass my rented house and torched. The approximate value of looted properties are estimated at Rs. 1,672,000/- (Rupees Sixteen Lakhs Seven two thousand) approximately.

Regarding the matters I could not register my F.I.R timely due to lack of legal Knowledge. It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
