Sir, With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 p.m. some unknown persons suspected to be Kuki militants open fired towards the Meitei populace of Engouruk Chingman, Kanto Sabal and Leimakhon Chingman and burnt/vandalized many houses of Meitei community. In the incident, the said unknown persons had looted (five) number of pig. and 4 (four) number of cows had not returned home suspected to be killed by Kuki militants. The approximate value of lost/looted properties is estimated around ₹ 1,60,000/- (Rupees One Lakh Sixty Thousand).

Regarding the matter, I couldn't be able to report due to till date due to the present situation of the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
