With due respect, I have the honour to report the following few lines that due to the ongoing communal crisis between two communities. On 29/05/2023 at around 11:00 pm, I have come out from my house and taking shelter at one of my relative house by keeping my house under locked and Key. On 08/08/2023, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass my house and looted my belongings properties i.e. furniture, kitchen items, utensil, clothing, electronics items, Cash (Rs. 7,19,000/-), jewelry, 3 nos. of Goats and 5 duck by breaking the Lock and key which I had locked. The approximate value of the properties is Rs.13,00,000/- (Thirteen Lakhs).

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
