Sir,

With due respect, I have the honour to state the following few lines that, I along with my children have staying at my parental home (i.e Khoisnam Pratima Devi) located at Leimakhong Chingmang, IW District since last 2 years back which is under the control of Kuki arms militants since the beginning of the current communal riots. On 3/5/2023 at around 8:00 pm, I along with my children have fled away from my parental home due to fear & safety of life and taking shelter at Lairikyengbam Leikai.

However, on 1st September, 2023 at @ 10:00 am, many local women folk including local volunteers have visited at our respective houses for checking with the help of Indian Army and found that my parental house including my room were vandalized and the undernoted valuable properties were found missing from my room which was suspected to be looted by Kuki armed militants/miscreants in between 3rd May, 2023 to 31st 2023.

The properties that were vandalized & looted are as follows:-

- 1. One room (vandalized) = Rs 50,000/- approx.
- 2. Machine (one) = Rs 15,000/- Approx
- 3. Refrigerator (one) = Rs 16,000/- Approx
- 4. Cash = Rs 7 lakh (which were kept inside iron godrej)
- 5. Iron godrej (one)= Rs 15,000/- approx
- 6. Furniture items = Rs 1 Jakh /- approx.
- 7. Tailoring machine (one) = Rs 10,000/- approx.
- 8. Others Electronic items = Rs 51,000/- Approx
- 9. Utensil items = Rs 30,000/-Approx
- 10. Jewelry = Rs 1 lakh approx

Grant total = Rs 10,87,000/- approximately

It is therefore requested you to kindly take up necessary legal action.
