Sir,

With due respect, I have the honour to state the following few lines that, I have one garage cum godown located at Engourok Chingmang which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State. In this connection, I couldn't inspect my godown since 3<sup>rd</sup> May, 2023 due to present ethnic violence in the state.

However, on 2<sup>nd</sup> September, 2023, it comes to light that, my garage cum godown was destroyed and many valuable properties i.e (i) GI Sheet (50mm) – 30 bundles which were kept at the said gown (ii) 100 pieces of MS squar pipe 40 mm (iii) Lubricant approximate value Rs 1 Lakh (iv) Spare parts of Excavator & Back Hoe approximate value Rs 2.5 Lakh are missing which was suspected to be vandalized and looted by Kuki armed militants/miscreants in between 3<sup>rd</sup> May, 2023 to 1<sup>st</sup> September, 2023. The approximate value of the properties that were vandalized & looted is about Rs 10,50,000/- (Rs ten Lakh Fifty Thousand) approximately.

It is therefore requested you to kindly take up necessary legal action.
