With due respect, I have the honour to state the following few lines that, I am running one electrical shop "Nongthombam Enterprises" at Kanto Sabal near Leimakhong Chingmang which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State and my shop was closed since 3<sup>rd</sup> May, 2023 under proper locked and key due to fear and safety.

However, on 2<sup>nd</sup> September, 2023, it comes to light that, my valuable goods items of my shop i.e Electrical Items & lighting items (approx. value Rs 15 lakh) were looted by unknown persons suspected to be Kuki armed militants/miscreants in between 3<sup>rd</sup> May, 2023 to 1<sup>st</sup> September, 2023 after breaking the back side door of my shop.

It is therefore requested you to kindly take up necessary legal action.
