Sir,

With due respect, I have the honour to state the following few lines that, I have one rented apartment including two shop located at Leimakhong Chingmang near NP Hardware rented to two Nepali families since last 2 year back which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State. On 4/5/2023, the tenant of my rented apartment informed me that they are fled away from my rented apartment due to fear & safety of their life. In this connection, I couldn't inspect my rented apartment due to present ethnic violence in the state.


However, on 1<sup>st</sup> September, 2023 at @ 10:00 am, many local women folk including local volunteers have visited at our respective houses for checking with the help of Indian Army. On checking of my rented apartment, all the door keys & boundary wall fencing are found destroyed and valuable household materials i.e furniture items, 48 pieces of GI Sheet (.63 mm), 16 piece of 80 mm MS pipe, 26 piece of 40 mm MS square pipe, 23 piece of MS round pipe are also found missing which was suspected to be vandalized and looted by Kuki armed militants/miscreants in between 3<sup>rd</sup> May, 2023 to 31<sup>st</sup> August, 2023. The approximate value of the properties that were vandalized & looted is about Rs 6,50,000/- (Rs Six Lakh Fifty Thousand) approximately.

It is therefore requested you to kindly take up necessary legal action.
