Sir,

With due respect, I have the honour to state the following few lines that, I am resided at Leimakhong Chingmang which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State. On 3/5/2023 at around 8:00 pm, I along with my whole family had fled away from my home due to fear & safety of our life and taking shelter at Khurkhul till date.

However, on 1st September, 2023 at @ 10:00 am, many local women folk including local volunteers have visited at our respective houses for checking with the help of Indian Army. In that, the doors & windows of my house were found vandalized/destructed. On further checking it is found that, many valuable properties i.e furniture items, utensil items, electronics items, clothing, Kitchen items etc are also found missing which was suspected to be vandalized and looted by Kuki armed militants/miscreants in between 3rd May, 2023 to 31st August, 2023. The approximate value of the properties that were vandalized & looted is about Rs 10,50,000/- (Rs Ten Lakh Fifty Thousand) approximately.

It is therefore requested you to kindly take up necessary legal action.
