Dear Sir,

With Due respect, I have the honour to report the following lines that is , I am a residence of Leimakhong Ex- Serviceman Colony, I/W which is under the control of Kuki arms militant since the beginning of the current crisis. Due to the ongoing crisis between kuki& Meitei communities, I along with my wife & two daughter have escaped from my residence on 20 May 2023 & taking shelter at a friends house at Loitangkhunou after that we stay at kongpal relief camp organized by Industrious students association cum library home, kongpallai – hidden on from 6 June 2023 & we went to stay at my wife elder sister house at Sagolband from 24 August 2023 till now. It comes to heard that suspected to be kuki arms militant & kuki rioters had trespass my house & looted/Vandalized my properties i.e. furniture, kitchen items, cloths, electronic items, iron workshop tools, cash & Jewellery and others & the approximate value is around Rs. 13,00,000/- (Thirteen lakhs)

Regarding the matter I could not report till date due to the present crisis and my poor health issue. Hence I therefore reported to your office for further procedure.

So I therefore kindly request you to look into the matter & take up necessary action.
