Sir,

With due respect, I have the honour to state the following few lines that, I am resided at Leimakhong Chingmang opposite to "Premsing Farm House" which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State. On 4/5/2023 at around 1:00 pm, I along with my whole family escape from my home after proper locked and key due to fear & safety of our life and taking shelter at Kanto Sabal relief Camp till date.

However, on 1<sup>st</sup> September, 2023 at @ 10:00 am, many local women folk & local volunteers including myself have visited at our respective houses for checking with the help of Indian Army. On checking it is found that, many valuable properties i.e 3 cows, clothing, Gold (approx. value 1.5 Lakh) & cash (Rs 70 thousand), paddy rice bag – 80 no's, electronics items, furniture item etc are also found missing from my house which was suspected to be looted by Kuki armed militants/miscreants in between 4<sup>th</sup> May, 2023 to 31<sup>st</sup> August, 2023 after breaking the lock and key. The approximate value of the properties that were vandalized & looted is about Rs 6,55,000/- (Rs Six Lakh Fifty-five Thousand) approximately.

It is therefore requested you to kindly take up necessary legal action.
