The Officer-In-Charge Sekmai Police Station Imphal West District, Manipur.

Subject: - Report.

Sir,

With due respect, I have the honour to report the following few lines that, some unknown persons suspected to be Kuki militants opened fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and Leimakhong Chingmang area several times since 29th May 2023. Also torches/vandalized many houses of Meitei community. Regarding the incident of firing, several bullets reached our village as well as my residential area. As such, on 29th May, 2023, I along with my whole family members had fled away from my house due to fear & safe of our life and taking shelter at Kanto Sabal relief camp till date and 4 (four) number of my cows had not returned home till date which were suspected to be looted by Kuki armed militants. The approximate value of looted cows is estimated around Rs. 1,60,000/-(Rupees One Lakh Sixty thousand) approximately.

Regarding the matter, I couldn't report timely to your good office due to lack of legal knowledge.

It is therefore requested you to kindly take up necessary legal action.
