With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Ingourok Chingmang/Cooperative and vandalized many houses of Meitei. In that incident, the Kuki armed militant had looted our village committee property.

The property looted by kuki militant are listed below :
